NOTICE OF A PUBLIC HEARING

A Design Public Hearing will be held by MassDOT to discuss the proposed Intersection Improvements at Groton Road (Route 40) & Oak Hill Road in Westford, MA.

PURPOSE: The purpose of this hearing is to provide the public with the opportunity to become fully acquainted with the proposed Intersection Improvements project. All views and comments made at the hearing will be reviewed and considered to the maximum extent possible.

PROPOSAL: The proposed project consists of roadway and sidewalk improvements along Route 40 (Groton Road) from Russels Way for approximately 2,000 feet to the retail plaza driveway, and along Oak Hill Road from Betty Lane for approximately 800 feet to the rear of the gas station building. Improvements include new sidewalks, minor roadway widening, pavement resurfacing, a new traffic signal at the intersection of Route 40 and Oak Hill Road, and reconstruction of the culvert that conveys Gilson Brook under Route 40. Bicycle accommodations consisting of a 5' bicycle lane will be provided along Route 40 and shared use accommodations consisting of a travel lane with shared lane markings will be provided along Oak Hill Road.

A secure right-of-way is necessary for this project. Acquisitions in fee and permanent or temporary easements may be required. The town is responsible for acquiring all needed rights in private or public lands. MassDOT's policy concerning land acquisitions will be discussed at this hearing.

Written views received by MassDOT subsequent to the date of this notice and up to five (5) days prior to the date of the hearing shall be displayed for public inspection and copying at the time and date listed above. Plans will be on display one-half hour before the hearing begins, with an engineer in attendance to answer questions regarding this project. A project handout will be made available on the MassDOT website listed below.

Written statements and other exhibits in place of, or in addition to, oral statements made at the Public Hearing regarding the proposed undertaking are to be submitted to Patricia A. Leavenworth, P.E., Chief Engineer, MassDOT, 10 Park Plaza, Boston, MA 02116, Attention: Roadway Project Management, Project File No. 608036. Such submissions will also be accepted at the hearing. Mailed statements and exhibits intended for inclusion in the public hearing transcript must be postmarked within ten (10) business days of this Public Hearing.
