CAPITAL APPROPRIATIONS - FISCAL YEAR 2018

ARTICLE 1:	Approve Capital Appropriations	<i>Permanent Town Building Committee</i>
To see if the Town will appropriate by taxation, by transfer from available funds, by borrowing, or any combination thereof, the sum of \$325,000 (THREE HUNDRED TWENTY FIVE THOUSAND DOLLARS) to provide for the following capital requests and all costs incidental and related thereto:

Public Safety Communications	\$325,000	Construction and equipment expenses for the combined police and fire dispatch center

Or act in relation thereto.


ARTICLE 2:	Abbot School MSBA Project	<i>School Committee</i>
To see if the Town will vote to appropriate, borrow or transfer from available funds, the sum of \$50,000 (FIFTY THOUSAND DOLLARS) to be expended under the direction of the School Committee, in conjunction with management oversight by the Permanent Town Building Committee for a Schematic Design Study for a potential partial or complete roof replacement project at the Abbot Elementary School located at 25 Depot Street, Westford, MA 01886, including any other costs incidental and related thereto, for which schematic design study the Town may be eligible for a grant from the Massachusetts School Building Authority. The MSBA's grant program is a non-entitlement, discretionary program based on need, as determined by the MSBA, and any costs the Town incurs in connection with the schematic design study in excess of any grant approved by and received from the MSBA shall be the sole responsibility of the Town,		


Or act in relation thereto.

THEREOF FAIL NOT and make return of this warrant, with your doings thereon, to the Town Clerk, at the time and place of holding the meeting aforesaid.


